

Northland Foundation announces 35 quarterly grants awarded July through September

More than one-third of funding went toward helping sustain and expand child care in northeast Minnesota

From July through September, the Northland Foundation awarded 35 quarterly grants totaling \$603,500 to support northeast Minnesota people and communities working toward a future where everyone feels they belong and can thrive.

In addition to awards to nonprofit organizations, Tribal nations, and school districts, the foundation directed over one-third of all grant funds last quarter – more than \$200,000 – to help sustain and expand licensed child care in the region.

The Northland Foundation has prioritized early care and education for more than 20 years with training and education, partnership development, funding, advocacy, rallying around the topic. During the past year alone, the Northland Foundation has, in collaboration with government partners, invested nearly \$800,000 to assist with stabilization and expansion of existing child care and start-up of new child care businesses. Northland has also administered millions of dollars in Minnesota Early Learning Scholarships to help families in the region pay for high-quality care and led programming to support "informal providers" who regularly care for the children of family members, friends, and neighbors.

Need, however, continues to outpace efforts to increase child care access. According to the 2023 Child Care Needs Summary report newly released by First Children's Finance, the current child care shortfall in northeast Minnesota is 4,223 slots – a loss of 500 slots since June 2022 when the shortfall was reported at just over 3,700. Tony Sertich, Northland Foundation President, has been closely involved with the child care issue at the local, regional, and state levels.

"The State of Minnesota took strong positive steps this year to help stabilize child care, and we can't take our foot off the gas now. Northland will keep doing what we can alongside public and private partners," said Sertich.

"That said, from all our work on child care, it is clear that a quick-and-easy fix does not exist especially in relation to infants and toddlers," continued Sertich. "There is no silver bullet. It will take broad community engagement, the courage to try new and different approaches, and significant public investment to reach long-term solutions that work for families, early care and education providers, and employers."

The child care expansion grants and all Northland Foundation quarterly grants awarded July 1 – September 30, 2023, are as follows.

<u>BASIC NEEDS GRANTS</u> Food security, homeless services, affordable housing, and other human needs essential to wellbeing

To provide general operating support to YWCA Duluth's mission to eliminate racism, empower women, and promote peace, justice, and freedom for all.

Churches United In Ministry, Duluth: \$30,000

To support the staff, residents, and broader community of the St. Francis Apartments in Duluth.

Project Care Free Clinic, Hibbing: \$25,000

To maintain operations of Project Free Care Clinics in the Iron Range.

Planned Parenthood of Minnesota, North Dakota, and South Dakota, Saint Paul: \$20,000

To provide comprehensive and culturally specific sex education to BIPOC residents of the Duluth area.

Children's Dental Services, Inc., Minneapolis: \$30,000

To provide comprehensive dental care and substance use prevention education to women and pregnant people who have experienced domestic violence and their children and family members in northeast Minnesota.

To support LGBTQ+ equity, inclusion, and belonging in St. Louis County, Cook County, and the Fond du Lac Reservation.

DOMESTIC VIOLENCE AND ABUSE PREVENTION GRANTS Prevention and intervention in relation to domestic and family violence, sexual assault, and human trafficking

To support the Sexual Assault Nurse Examiner program that provides forensic medical exams and advocacy services to victims of sexual assault.
